INFORMATION ON THE PROCESSING OF PERSONAL DATA:**

Magdalena Abakanowicz University of the Arts in Poznań, having its registered seat at Al. Marcinkowskiego 29, Poznań, having the statistical identification number (REGON) 000275808 and tax identification number (NIP) 778 11 28 625, as the controller of my personal data (hereinafter referred to as, Organizer"), in accordance with Article 13 (1) and (2) of the General Data Protection Regulation of 27 April 2016 (hereinafter referred to as GDPR), I am providing the following information regarding the processing of personal data in connection with your participation in the "Illusion of Form" Project.

**A – Legal basis and purpose of processing:**

Personal data of the project participants (hereinafter "participants") submitted in the application form and made available during the Project (hereinafter "personal data") will be processed in accordance with the GDPR.

**Personal data will be processed by the Organizer:**

1. in order to make it possible for the Participant to participate in the Project - in such a case the basis of processing shall be the legitimate interest of the Organizer consisting in the realization of the Project; moreover, the basis for processing will also be the execution of the agreement on participation in the Project.;
2. in order for the Organizer to defend itself against possible claims or in order for the Organizer to assert possible claims related to the Participant's participation in the Project - in such a case, the legal basis for data processing is the Organizer's legitimate interest consisting in the possibility to defend itself against claims or to assert claims;
3. in order to fulfill the Organizer's obligations arising from legal regulations, related to the Project - in such a case the legal basis of data processing is the necessity of their processing in order to fulfill the legal obligation imposed on the Organizer;
4. in order to promote the activity of the Organizer and the Project (the Participant's image and data) - in such a case, the basis for data processing is the legitimate interest of the Organizer in promoting the Organizer's activity and the Project, in connection with granting consent to use the Participant's image and data for this purpose,

**B – Participant's rights:**
